Larchmont Charter did a comprehensive process in the spring of 2021 to gather input from our whole community including staff, families and students on the development of our plan to prevent and mitigate, to readjust to the return to full time in person learning, and to address the impact of learning loss. This process included outreach to our diverse community includes families of students with disabilities, homeless and foster youth, English Learners, and different racial, ethnic and linguistic backgrounds. This process included stakeholder surveys providing invaluable feedback on our program. These surveys were translated to ensure access for all in our community to engage. We also had parent coffees in Spanish and Korean to ensure access. We also did several targeted surveys. Our school leadership team (administrators including the special education administrator), our Employee Advisory Group, our Site Council, our Finance Committee and Board met on multiple occasions to strategize how best to allocate funds to ensure safety, to provide support during the transition back to in person learning, to identify and address missed learning following the pandemic. Larchmont's Senior Director of Student Learning and Support Services, our ELD Coordinators, and our homeless liaison frequently consult with LAUSD, LACOE, the CDE to learn about services to meaningfully address student needs. We also consulted with other school and district leaders, community groups and consulted resources from the County and State related to best practices in supporting homeless, foster youth, English Learners and struggling students. We had townhalls and public board meetings accessible to all to give input and feedback on plans.

There was consensus among stakeholders on the critical need to ensure the environment was as safe as possible to return. This meant prioritizing investing in testing, masks, improved ventilation, cleaning, a daily health checklist app, and support staff to assist with all this. We also recognized the need to rebuild community and focus on social emotional learning to address the trauma of the past year and a half as a prerequisite for accelerating learning. Lastly, there was consensus among both staff and families that additional support staff, training and planning, and additional intervention resources (paid time, adaptive software programs, assessment and intervention programs and more) were the highest priorities to address learning loss. These community-generated priorities are reflected in this plan.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
